24/24 WARRANTY INFORMATION:

All remanufactured **Engines** are warranted against defects in workmanship and material for a period of 24 months or 24,000 miles, whichever occurs first. A warranty claim number and return goods authorization must be issued by manufacturer before any repairs are begun. Return freight to factory is for buyers account for warranty analysis. Authorized repair or replacement of original unit does not extend warranty period. Repair or replacement is at the sole discretion of the Seller. Return freight of warranted units will be at standard delivery rates for seller's account. Warranty card must be completed, signed and returned to Seller for warranty coverage activation, otherwise warranty will be VOID.

EXCLUSIONS:

This warranty does not cover damage due to abuse, neglect, accidental breakage externally or internal gear breakage, lack of lubrication, excessive heat, incorrect fluid, or use for any purpose other than originally intended. In no event shall the Seller be held responsible for any consequential or incidental damages from the use of a product or improper installation. Original manufacturer's maintenance schedules must be maintained by buyer with records available upon request of Seller. LIMITED WARRANTY:

Labor expense for removal and replacement, when included as part of the warranty, will be calculated from the Chilton/Mitchell/Motors manual for hourly time guides at the factory approved rate. Hourly rate for ASE certified technician is \$50.00 per hour and non-certified technician is \$30.00 per hour with the total maximum labor capped at \$500.00.

JURISDICTION, VENUE, AND ARBITRATION disputes and controversies of every kind nature between Adams Diesel Engines and Purchaser, arising out of or relating to this agreement, transaction or purchase, shall be settled by mandatory binding arbitration in McClain County, Oklahoma in accordance with Oklahoma arbitration law.
